Dear Members:

Welcome to the 2018 season of the Allenhurst Beach Club. This year we are happy to announce that applications can once again be completed and submitted online. New this year, all information (address, phone number and email address) will be required for all adult members listed on the application. An application will not be accepted without this information. This will allow the club to be able to communicate to all members about announcements, events and happenings rather than just the principal.

The beach club will open Memorial Day weekend, Saturday May 26, thru Monday, May 28<sup>th</sup> and will be open weekends until June 16<sup>th</sup>, at which time the club will be open daily thru September 9th. Beach Club hours will be from 10:00 am till 7:00 pm all summer.

We are currently replacing the old pool deck with stamped concrete. The old awnings surrounding the pool are being replaced with new permanent structures. A sprinkler system is being installed for the grass area on the North side of the pool. Both North and South side walls by the lockers will also be replaced. These renovations are part of our continued effort to improve the look and feel of the club.

Each member must have a current picture on file to enter the Beach Club. An audit of all memberships will be performed prior to the club opening. You can have your picture taken at any of the club entrances. Memberships will be suspended until all members of each facility have their picture on file. If you are unsure if all members of your facility have their picture on file, please check with the office. Suspension or revocation of memberships will be enforced should members disregard this policy.

Packages of 2018 Guest tickets will be sold in groups of ten (10) passes for \$150.00. New this year, if purchased on or before May 31, 2018, the packages of 2018 Guest tickets will be sold at the discount price of \$130. Please see the Membership Information section for further details.

Chair tags will be required this season for all chairs. Each member is allowed one tag. New 2018 tags will be issued at the main entrance. Any chair that is left on the beach without a tag will be removed and brought to the DPW yard.

The Recreation Program and Swim Team will be returning this year under the direction of Warren Towns. The program shall be open to all children who are members of the Allenhurst Beach Club between the ages of five years and twelve years, at the discretion of the Recreation Director. More information on the program will be available at the Club.

Tina Pritzlaff, our yoga instructor will be returning to teach yoga on the oceanfront. Heather Wanner will be back to direct the youth dances. The SS Allenhurst shuttle bus will be once again running. We encourage members in neighboring towns, as well as Allenhurst residents, to utilize the bus service as needed.

The Allenhurst Fire Department will once again be selling raffle ticket to win a prime parking space at the Beach Club. The winners will be able to pick a spot either at the cabana or main entrance. The drawing will be June 24<sup>th</sup>.

We are all looking forward to a great summer and wish you and your family an enjoyable season at the beautiful Allenhurst Beach Club.

## ALLENHURST BEACH CLUB RULES

1. IDENTIFICATION – NO ONE will be permitted entrance into the Beach Club without being identified as a member or guest of a member. Identification points will be set up at each Beach Club entrance for member's convenience. Each member must have a current picture on file to enter the Beach Club. Memberships will be suspended until all members of each facility have their picture on file. Suspension or revocation of memberships will be enforced should members disregard this policy
2. GUESTS – Guests MUST be accompanied by a Club member. Guests are permitted into the Club with Daily Guest passes only – no daily bracelets are permitted. Any member found bringing a guest into the Beach Club without paying the prescribed fee shall be subject to revocation of membership and such guest shall be subject to prohibition of use of the facilities as well.
3. ENTRANCES – Prior to the opening of the Beach Club, members and guests may line up at the Club entrance. Under no circumstances are members or guests permitted to leave personal belongings, such as beach bags towels, etc., as a substitute or in lieu of their presence at any Club entrance, as a means to reserve their place in line for Beach Club entry. All unattended items found placed at the entrances shall be removed and turned over to the Allenhurst Police Department for safekeeping.
4. DAMAGE OR LOSS OF ARTICLES – The Borough of Allenhurst will not be responsible for damage or loss of equipment, clothing, bathing apparel, or valuables left in any part of the establishment, whether or not same has been entrusted to ABC employees or checked with management.
5. GLASSWARE – Absolutely no bottled goods may be used at any location around the pool or deck area.
6. RECYCLING – Members are responsible for using the appropriate receptacles for discarding all refuse and recyclables as required by Borough ordinance.
7. LOUNGES – Lounges are for the use of all members and guests on a first come basis and may not be saved or rearranged from one location to another, or from one deck area to another deck area. Only one lounge shall be permitted per member or guest.
8. PLAYPENS/STROLLERS – Playpens will be allowed by the main gate area and the deck pavilion area. Strollers are not permitted to be walked around the pool area.
9. CHILDREN – ALL children under the age of 5 years old must be listed on this application and must have a copy of a birth certificate attached to the application. Children under 12 must be accompanied by an adult. Parents/guardians are responsible for the conduct of their children at all times. Unruly and unmanageable children will be asked to leave.
10. KEYS – Each bathhouse will receive two keys for the season. Beach Club staff will be available to assist you with entrance to your bathhouse as necessary.
11. TRESPASS – Anyone entering the Beach Club unlawfully will be subject to fines per Ordinance 2009-16.
12. PETS – No dogs, pets or other animals are permitted on the ABC property, which includes the boardwalk.
13. KAYAKS – A kayak rack will be available at the rate of \$100 for the season. Space will be allocated on a first come, first served basis. There will be a specific marked lane for the kayakers to use when entering or exiting the ocean. Kayaks remaining after season's end will become property of the Borough.

14. BATHING – Bathing and surfers are forbidden to bathe/surf outside designated areas, or at such times, when in the professional opinion of management or lifeguards, ocean bathing is dangerous or unsafe. Bathing after hours is prohibited.
15. DANCES – Summer youth dances are sponsored solely by the ABC and will, therefore, be strictly limited to ABC members and residents of Borough of Allenhurst.
16. GROUNDS – Members and guests will cooperate in keeping beach pool areas, grounds and other ABC facilities in clean condition. Deck, stairs and passageways shall not be obstructed by members or guests. Anyone defacing or damaging any ABC property, including, but not limited to lockers, cabanas, etc., shall be subject to immediate expulsion from the Club and prosecution to the full extent of the law. No Smoking is allowed in the beach club facility or in or near any cabanas. During beach club hours, smoking on the beach and boardwalk will only be permitted in designated areas and all smoking related trash must be disposed of in designated receptacles. Any violation of these smoking restrictions shall be grounds for loss of beach club membership privileges in addition to any statutory fines.
17. WADING POOLS – Children’s wading pools on the beach are not to exceed 52” in diameter and 11” in depth. THIS RULE WILL BE STRICTLY ENFORCED.
18. DIAPER CHANGING - Diaper Changing is permitted in Lockers and Rest Rooms Only.
19. NORTH DECK RULES – Chairs and lounges only. No savings of lounges. No playpens or cribs allowed. No moving of furniture. No food of any kind.
20. SOUTH DECK RULES – Chairs and lounges only. No savings of lounges. No playpens or cribs allowed. No moving of furniture.
21. FOOD DECK – All members are allowed to eat on the restaurant food deck.
22. BEACH DECK AREA – No toys stored of any kind. All toys shall be stored overnight in the owner’s locker.
23. MEMBERSHIP CAP – Beach Club Membership is closed for 2018. Allenhurst residents and those persons who were Beach Club members during the prior Beach Club season will be approved for Club membership.
24. ADDITIONAL RULES – The management may put into effect, at any time, rules that are considered of benefit to the Beach Club or its patrons.
25. GENERAL CODE OF CONDUCT – In addition to the foregoing rules, each member and their guests are expected to be respectful to all staff and fellow members at all times. The goal of all ABC staff is to provide a peaceful family friendly environment and appropriate behavior from members and guests is the only way to achieve that goal. Therefore, loud and/or offensive language and obscene or otherwise inappropriate behavior is forbidden. Moreover, only the Club management is responsible for instructing and disciplining staff. Members and guests shall not criticize or denigrate ABC staff in any way. Although members are encouraged to report immediately to any Club employee any conditions or actions deemed hazardous to health and safety, complaints by members about staff behavior and job performance shall be made only to management. To ensure that such complaints are received and addressed appropriately, all complaints should be reduced to writing, signed by a member and left with management or e-mailed by a member to the Board of Commissioners.
26. CANCELLATION OF MEMBERSHIP – The management reserves the right without refund of any payment to suspend or revoke membership privileges of anyone violating these rules. This includes resident and non-resident members and guests. Revocation of membership may be for one day, one week, an entire year or for life. Decisions may be appealed at a regular meeting of the Board of Commissioners.
27. CHAIR TAGS will be required this season for all chairs. Each member is allowed one tag. New 2018 tags will be issued at the main entrance. Any chair that is left on the beach without a tag will be removed and brought to the DPW yard.

## MEMBERSHIP INFORMATION

1. **GUEST PACKAGES:** Packages of 2018 Guest tickets will be sold in groups of ten (10) passes for \$150.00. If purchased on or before May 31, 2018, the packages of 2018 Guest tickets will be sold at the discount price of \$130.00. There is no limit on the number of packages that may be purchased but, be advised that they are **only valid during the 2018 season**. Children under age 3 are free. **GUESTS WILL BE ADMITTED ONLY WHEN ACCOMPANIED BY A CLUB MEMBER. THIS RULE WILL BE STRICTLY ENFORCED. Guest Passes purchased in 2017 will be honored in the 2018 Season.**
2. **MEMBERSHIP:** Each bathhouse shall not exceed 8 persons and each cabana shall not exceed 10 persons.
3. **RESIDENCY:** When filling out a resident application, please include as residents only those people who reside in Allenhurst during the summer months. Applications will be checked for accuracy.
4. **APPLICATION AND PAYMENT DEADLINE:** Your application is due on or before April 9th, 2018. If your application is not received by this date, you will forfeit your facility. **THERE WILL BE NO EXCEPTIONS.** If you will not reserve your facility in 2018, please notify Allenhurst Borough Hall by phone or e-mail. Payment in full is due on or before May 11, 2018. After May 11, a late fee of \$250.00 will be assessed.
5. **PAYMENT:** Payment in full will be accepted **ONLY** from the principal applicant named on the application. There will be a \$20.00 returned check charge. All requests for membership refunds must be filed by July 1, 2018.
6. **SHARING A FACILITY:** When a resident and non-resident are co-principals and share a facility, the charges shall be half the fee for a Resident, to be paid by the resident, and half the fee for a Non-Resident, to be paid by the non-resident.
7. **RENTALS:** If an applicant plans to rent in Allenhurst during the summer months, a Certificate of Occupancy must be presented in order to obtain resident rates. Summer renters are considered members for the current season only. Membership will not automatically be renewed. Allenhurst homeowners who are renting their homes for the summer will be subject to non-resident rates.
